আমতার থলিয়া গ্রামপঞ্চায়েত এলাকায় 'সেহাগডি' পানীয় জল সরবরাহ প্রকল্পে বাডি বাডি জলের সংযোগ দেওয়ার কাজ শুরু হল। শুক্রবার এই কাজের সূচনা করলেন স্থানীয় বিধায়ক ও বিধানসভার উচ্চশিক্ষা বিষয়ক স্ট্যান্ডিংকমিটির সদস্য সুকান্ত পাল। এই প্রকল্প থেকে থলিয়া গ্রামপঞ্চায়েতের ভাতেগড়ি, ধাইপুর, মইনান ও সেহাগড়ি— এই ৪টি মৌজার ২,৭২১টি পরিবার উপকৃত হবেন। ১ কোটি ৭৩ লক্ষ টাকা ব্যয়ে এই প্রকল্পের কাজ দেড মাসের মধ্যে শেষ করার লক্ষ্যমাত্রা রাখা হয়েছে। আমতা-২ ব্লকের প্রতিটি পঞ্চায়েতেই বাড়ি বাড়ি পানীয় জলের সংযোগ দেওয়া হবে। পঞ্চায়েত ও জনস্বাস্থ্য কারিগরি মন্ত্রী পুলক রায় জানান, মুখ্যমন্ত্রী মমতা ব্যানার্জির নির্দেশে ২০২৪ সালের মধ্যে রাজ্যের গ্রামীণ এলাকার প্রতিটি বাড়িতে পানীয় জলের সংযোগ দেওয়া হবে।
